   (Refer NOTAM # A1303/19): RWY 10/28 not available for ops due maint. between 2131-2330 UTC.
- VECC: (Refer NOTAM # A1632/19): RWY 19L/01R not avbl for Ops due scheduled maint. work from 1900 –
   2300 UTC, WHEN VISBILITY 1200 M OR ABOVE. During this period Rwy 19R/01L will be avbl for unrestricted ops. 30 min prior notice for avbl of Rwy 19L/01R
