- VIDP: (Refer NOTAM #A0156/20) RWY 11/29 not available for ops due maint. between 1830-1930 UTC. (Refer NOTAM #A0154/20) RWY 10/28 not available for ops due maint. between 1931-2330 UTC.
- VOMM: (Refer NOTAM #A0293/20) No ARR/DEP permitted on RWY 07, no arrival permitted on RWY25 from 0830-0930 UTC. RWY25 AVBL for DEP from Taxiway "C" only. Rwy12/30 is AVBL for Taxi and helicopter ops only. (Refer NOTAM #A0405/20) Due Scheduled maint. of RWY 07/25 FRM 0930-1130 UTC only secondary RWY 12/30 available for ops.
- VECC: (Refer NOTAM #A0171/20 from time 1900-2300 UTC) Due to SKED Maint work, RWY 19L/01R not avbl for OPS when VIS 1200M or above. During this period, RWY 19R/01L AVBL for Acft OPS.
