Operation of all SKD/Non-Scheduled Domestic Flights (Except all Cargo Flights, off-shore helicopter operations, medical evacuation flights or flight specially approved by DGCA) by any Aircraft Operator shall cease with effect from 1829 UTC ON 24 MARCH 2020 TILL 1829 UTC ON 17 MAY 2020. (Refer NOTAM# G0255/20). Stakeholders will be notified 4 hours before ATFM Measures are initiated. Publication of CTOTs: 02h 15m before the CDM begin time.
